

One-Year PhD Training in Gender Studies (Utrecht University, NL)

The Netherlands Research School of Gender Studies (NOG, Utrecht University) offers a one-year interdisciplinary programme (10 months) for graduated MA students and PhD students from abroad. The training package consists of NOG courses and research seminars. All courses are taught in English from multicultural, (Western) European perspectives. A certificate is issued after completion of each individual course. Please note that this training doesn't officially constitute a MA or PhD degree, although an ECTS system is in place. The Dutch academic year runs from September to the end of June. The one-year PhD Training starts yearly in September.



Pre-requisite for admission: a Master's degree or the equivalent of a MA in gender or gender-related areas. The NOG Board will make a profound evaluation about the global value of your foreign higher education.

These lectures stress the importance of doing gender work combined with an active involvement in the practice of gender theory and research. Professor Tina Chanter (Kingston University London, UK) a lecture on Wednesday May 18, 2016. Professor Chanter's research currently focuses on questions of aesthetics and politics. Recent publications have interrogated the philosophical, psychoanalytic and literary reception of Sophocles' tragic heroine Antigone, an analysis of abjection in contemporary, independent film, and the need to reflect on how to theorise gender in a manner that explores its intrinsic and complex relationship to other categories such as race, class and sexuality. Her work is informed by figures such as Levinas, Derrida, Irigaray, Kristeva, and Rancière. Public lecture LJ Müller (University of Groningen, NL)

L J Müller (Humboldt University, Berlin, DE) will give a public lecture on 'The Sound of the Phallus. How gendered desire is produced in popular music' at the University of Groningen (NL). The lecture is to be held on April 11, 2016, from 17.00-18.00 hrs.

It is no secret that popular music is highly sexualised. But there has been little discussion on how cultural images of eroticism or "sexyness" are produced by sound and how these might differ in relation to gender. Müller will pose these questions using performance theory following Judith Butler and Suzanne Cusick and psychoanalysis – according to mainly Jacques Lacan – for music interpretation. Furthermore Müller wants to aim for some implications of this finding as it points not only to a body-performance of one's sex but even a performance in relation to one's own body. The lecture is free and open to the public. **Registration** is not required.

Ponzanesi is Professor of Gender and Postcolonial Studies at the Department of Media and Culture Studies and Head of the Humanities Department at University College Utrecht (UCU). She is the project leader of 'Digital Crossings in Europe: Gender, Diaspora and Belonging' (CONNECTINGEUROPE, 2015-2020), for which she received a prestigious ERC Consolidator Grant of 2 million euros from the European Research Council. **Registration** is not necessary.

Linköping University (Sweden) hereby advertises two positions as student in Gender Studies formally based at the Department of Thematic Studies. As a PhD student you will primarily devote to your research. You are limited to work with education and administration up to 20 percent of full time. The teaching will be in English. The first dissertation project shall focus on a topic that spans the generative tensions of gender, nature and culture. The second dissertation project shall have focus on the postcolonial feminisms and consider artistic, social and cultural movements and phenomena as agents of epistemic, affective and political decolonization. The appointment will be until further notice for a maximum of one year at a time. A doctoral student may not be employed during a period exceeding eight years.

COST Scholarship 'In Search of Transcultural Memory in Europe'

The Research Network In search of transcultural memory in Europe (ISTME) invites applications for short term scientific missions (STSMs) in 2016. These Missions (Exchange Visits) are aimed at supporting integration and networking activities by allowing scientists to go to an institution in another COST Country to foster collaboration and/or to profit from expertise available at the host institution. ISTME is a COST funded Action that aims to go beyond the nationally oriented memory studies and tendencies to reify the bond between culture, nation and memory. Instead we investigate the transcultural dynamics of memory in Europe today. STSMs are particularly intended for PhD-students, post-docs and early stage researchers (PhD + 8 years). Exceptions can be made for senior scholars if the aim with the visit is writing an application for European funding involving partners from the COST-action ISTME IS 1203. **Deadline** for application is May 15, 2016.

Conference 'Reading Coetzee's Women' (Monash University, IT)

Call for papers for the conference 'Reading Coetzee's Women', to be held from September 27-29, 2016 at the Monash University (Italy). There has been enormous international scholarly interest in J.M Coetzee's writings in recent years. Since 2009 alone, four major international conferences (Sydney, Wuhan, Leeds and Adelaide) have been held and two biographies/literary biographies, ten monographs and over three hundred articles have been published on his work. Despite this, very little has been written on what we are calling, as a deliberate provocation, 'Coetzee's women': on his female narrators and characters or on the women writers who have influenced him, been drawn on by him and have been compared with him. This three-day international conference asks preeminent and emerging scholars to bring their attention to bear on 'Coetzee's women', broadly conceived, as well as possible reasons for the lack of sustained critical engagement with this theme until now. An intended outcome of this conference will be an edited volume of scholarly essays. **Deadline** for submission of abstracts is April 15, 2016.



Special Issue: Gender & the Politics of Shame

Hypatia: A Journal of Feminist Philosophy seeks contributions for a special issue on 'Gender and the Politics of Shame'. Significant advances in recent years in the development of shame theory make this issue especially timely. The issue will evince unprecedented feminist scholarly interest in affect and the politics of emotion. Shame has been theorized as a particularly gendered emotion, given women's frequent inability to act as authors of shaming narratives in patriarchal societies. This special issue on the gendered politics of shame interrogates the relationship between gender, shame, and power. It examines how the politics of shame comes to be enacted against a variety of normatively transgressive bodies and subjectivities, and how shame informs the construction, inter alia, of gendered, racialized, and classed Others. Inversely, it asks how Others respond to their construction as shameful. How have feminists subverted shaming narratives, or indeed, performed a politics of shame in the service of liberatory projects? **Deadline** for submission is December 1, 2016.
